National Salt Reduction Initiative

From 1970 to 2000, sodium intake increased by 55% in the United States. High blood pressure has become endemic in the U.S. and the "direct and progressive relationship between sodium intake and blood pressure has been well established." Yet, the average American consumes twice the amount of recommended sodium each day. Nearly 80% of this intake can be attributed to packaged and restaurant foods, which are not restricted by federal regulations limiting sodium content. [more]

From the Board of Directors The Treasurer's Report

The sound financial position of the College has allowed us to keep our dues low while offering more services to our members. In a typical year, the College brings in approximately what it spends or between \$250,000 and \$300,000. In 2010 the College had revenue of \$285,000 and spent \$311,000. Our major sources of revenue were membership's dues (45%), annual meeting and workshops (41%), journal royalties (10%), and our investments (5%). Our major expenses are the annual meeting and the workshops (20%), supporting services (35%) and the journal (26%). [more]

The goal of a recent ACE workshop was to review processes by which epidemiologic evidence is translated into policy and thereby to encourage epidemiologists to systematically evaluate their experiences and improve their practices.
